I'm looking forward to sharing a little bit about the work the Vermont Library Association has done over the past year and getting feedback from you about where and how VLA can improve its connections and service to members. Here are a few things I hope to discuss and discover at the unconference:

1. Learning more about library advocacy at all levels, from our grassroots efforts with our local government to contact with state and federal officials. This unconference conversation will be a great preface to the ALA Advocacy Bootcamp which will be offered as a pre-conference event at the joint VLA-NELA conference in October.
2. Working on a sustainable libraries resolution with an eye to developing a sustainable libraries initiative. Such an effort, modeled after the New York Library Association initiative, would provide a framework to guide and inform the design and implementation of sustainable solutions in libraries of all sizes across Vermont.
3. Participating in conversations about information literacy and civil community. We all understand the library's responsibility to provide access to information as well as the guidelines for ensuring that Vermonters are information literate. How do we make sure that notion does not get lost in the swirl of fake news and alternative fact? At the same time, libraries can serve as the showcase for respectful back and forth dialogue about the issues we face.

Vice President's Letter

It's been an exciting and busy few months for libraries. With threats of cuts to federal library funding looming, librarians in Vermont and beyond rallied to make our voices heard. There was a huge push from ALA and other library advocates for people to call and write legislators asking them to support funding for Innovative Approaches to Literacy and the Library Services and Technology Act. And support did significantly increase, presumably at least partly because of those efforts. There is of course still much work to be done. ALA is doing a terrific job of funneling information to members and providing accessible ways to participate in advocacy. We will continue to share these on the VLA website (www.vermontlibraries.org) and Facebook page, so check in as the good fight continues!

This was a good opportunity to bring library advocacy local, too. Almost everyone has heard about the threats to PBS and NPR. Discussions about those more "famous" programs have been serving well as introductions to remind people that local libraries are affected by federal funding, too.

These efforts came right up to National Library Week, during which many libraries participated in Library Snapshot Day (<http://www.ala.org/advocacy/advleg/statelocalefforts/snapshotday>). I love Library Snapshot Day. It is not only a great tool to use in promoting the relevancy of libraries when budgets are being discussed, but it also is just a super feel-good: to look at the statistics and stories from one day magnifies even for we library lovers how much important community building and education and creativity happens in our buildings each day. Share with staff, trustees, volunteers – it's terrific for morale and a reminder that the (let's face it, often underpaid) work library people do has a measurable impact. Get it outside the building via social media and your local news outlets and even some library patrons and supporters might be surprised to see the size and character of the "snapshot."

Looking ahead, National Library Legislative Day (which is actually more than one day) is May 1st and 2nd. Vermont will be represented by a mix of public, school, and state librarians, a small but hopefully metaphorically loud group. Those unable to attend can participate virtually. Find information about that here: www.districtdispatch.org/2017/04/participate-nlld17-home. An easy but dramatic way you can get people's attention is to participate in the "Thunderclap," the same message simultaneously going out on multiple social media platforms and accounts. Looking ahead, and in the spirit of "let's pause and reflect on how many great things are happening in Vermont Libraries even as we continue to advocate," the Passport to Vermont Libraries program is returning this summer. More information is on the VLA website www.vermontlibraries.org/passport. Passports have been created, and we'll be ready to distribute them at the conference May 18th, which hopefully many of you will attend!

Anchoring Information Literacy through Assessment

Last month, academic librarians from across the country flocked to Baltimore, Maryland for the biennial ACRL conference. I was pleased to see so many from Vermont had been able to make the trip and was proud to learn that two of our fantastic colleagues from Champlain College were leading a workshop at the conference. After hearing of their success, I invited Sean Leahy to share some of that experience with you now.

Sean Leahy: At this year's ACRL Conference in Baltimore, Alan Carbery and I had the good fortune to run a workshop on longitudinal information literacy assessment. During the three-hour workshop, we invited participants to take part in the "assessment loop" that our teaching librarians team performs each semester. The workshop had two primary goals. First, we gave participants the opportunity to engage directly with authentic student artifacts—that is, work produced for their class rather than developed and delivered by librarians separate from what is assigned in class. In doing so, we wanted to expose our colleagues at other institutions to the unique value of using authentic student work for assessment purposes. Second, we then asked participants to use their assessment findings to revise and improve their instruction so they could get experience with "closing the assessment loop." While the workshop was largely framed by the context at Champlain, we invited participants throughout to draw connections to and share insights from their own institutions and information literacy programs.

Alan and I have had the chance to share the results of our assessment efforts in forums like this in the past, but this was our first opportunity to present our IL program as a part of a workshop. We loved the idea of working within this format, as it felt as though we were inviting our colleagues from different institutions into the collaborative space we've cultivated at the Champlain College

Library. For us, this workshop was as much about communicating our assessment process as it was about sharing how our values as a team shape and are shaped by that process. Although the content we prepared highlighted the nuts and bolts of our process, the questions raised by participants throughout helped highlight some of the more intangible aspects of our assessment work that are not always captured in the documentation of our approach. It was gratifying to be able to share our work with colleagues from other institutions, and we received valuable insight from the participants as they engaged with important aspects of our information literacy program. If any of this is of interest, we encourage our Vermont colleagues to get in touch with us with any questions.

Beth Dietrich: Congratulations to Alan and Sean for their rewarding experience leading academic librarians through the process of meaningful information literacy assessment. I encourage you all to seek them out at the ACRL-NE conference in Burlington on May 12 where they, as well as many of our other Vermont colleagues, will be presenting.
