## President's Letter

What a difference a year can make! A year ago we faced a great deal of uncertainty about what the future would hold and how much longer we would have to continue to live and work with the enormous challenges of this terrible pandemic. And while we are in no way completely out of the woods, with the uncertainty surrounding the Delta variant and with some of our most vulnerable fellow citizens unable to get vaccinated, it does feel like we have turned a corner and can turn our attention to rebuilding and learning from this experience. It is with this context that I want to share some of the important work that the Vermont Library Association has in the works.

- **Working Group on the Status of Libraries in Vermont.** The state of Vermont has legislated that the state library form a working group on the status of libraries in Vermont (<https://legislature.vermont.gov/Documents/2022/Docs/ACTS/ACT066/ACT066%20As%20Enacted.pdf>) that will inform how the state supports our work. The working group will be chaired by our State Librarian Jason Broughton. VLA is charged with naming individuals to serve on this group. VLA Vice President/President-elect Kelly McCagg will represent the VLA board. We are currently accepting nominations for two positions representing college and university librarians and one position representing library trustees. If you (or someone you know) are interested in serving, please contact me ([mdroy@middlebury.edu](mailto:mdroy@middlebury.edu)) by August 15, and we'll add you to the list of those being considered. Please include your name, your role, and your reason for wanting to serve.
- **Continuing our First Thursday Series.** Past President Kevin Unrath will continue his role as convener of our popular First Thursday series, which will remain online for this year. If you have suggestions for topics or speakers, please reach out to Kevin ([kunrath@shelburnevt.org](mailto:kunrath@shelburnevt.org)).
- **Listening Tours.** Now that we are (for the time being!) allowed to gather in person, we are planning to organize a set of listening tours across the state to help us better understand how VLA can best serve your needs and interests. Stay tuned for announcements of upcoming chances to meet with fellow library workers and representatives from the VLA board. If you are interested in helping to organize such an event in your region, please let us

help you. The people who make up the Executive Board, Section & Committee leaders and Representatives volunteer their time for VLA because they feel that it is important to be involved in an organization that benefits Vermont librarians and their profession as a whole. ## Public Libraries

Greetings! It is a pleasure to write to you for the first time in my role as president of the VLA Public Libraries Section. This year your vice president is Susan O'Connell, director of the Craftsbury Public Library. Over the coming year, the VLA Public Libraries Section will continue our work on the VLA public relations campaign and will begin a series of library site tours across Vermont. Last year the VLA Public Libraries Section rolled out an advocacy campaign in the form of five customizable posters (<http://www.vermontlibraries.org/advocacy>). The goal of this campaign is to communicate what Vermont public libraries, collectively, achieve for Vermonters, as well as to highlight specific contributions from public libraries at the local level. Each poster is designed to be easily editable, so public libraries can personalize the poster by inserting their own statistics. This year, we will make five new posters available to public libraries. While the posters are available for use at any time, this year we will also make a push for libraries to use the posters leading up to Town Meeting Day, in an effort to drum up some interest and support statewide.

The VLA Public Libraries Section will also organize two regional library tours this year, one in the fall and one in the spring. In October, several libraries in the Northeast Kingdom will offer tours (if you are a NEK library and want to be included, please email Susan). The libraries will be within short driving distance of each other, and the tours will be staggered, so you can make a day of it. This will be a wonderful opportunity to gather again in person, learn from each other, and be inspired by

# Government Relations & Advocacy

## Government & Advocacy

As members of the Vermont Library Association, you are valued advocates for library matters at the local, state, and national levels. We on the VLA Government Relations & Advocacy Committee welcome your suggestions and feedback as we try to promote and invite support for libraries and the communities they serve in Vermont.

We hope that you and your library have taken advantage of the American Recovery Plan Act funding that has been made available to us. We would like to extend our gratitude to the Vermont Department of Libraries for coordinating and managing the ARPA-IMLS library grants. What a great opportunity for Vermont libraries!

As State Librarian Jason Broughton mentioned in a recent phone meeting, there are even greater potential benefits coming to libraries with the introduction of the Build America's Libraries Act. The act is currently under consideration in the Senate Budget Committee, chaired by Senator Sanders. Here are some of the key points regarding this bill that you can use when contacting legislators:

- Libraries are crucial to achieving digital and educational equity and expanding economic opportunity.
- The Build America's Libraries Act would provide \$18 million to repair and upgrade public library buildings around Vermont.

## **ARPA Money**

The American Rescue Plan Act of 2021 (ARPA) designated \$200 million in pandemic response funding for the Institute of Museum and Library Services' (IMLS) Grants to States program. The Vermont Department of Libraries (VTLIB) has received \$2,135,819 in ARPA funding, of which it will make up to \$980,587.07 in grants available to public libraries to make one-time purchases through the ARPA Grants to Public Libraries for Equipment and Supply Purchases program ([https://libraries.vermont.gov/ARPA2021\\_PublicLibraries](https://libraries.vermont.gov/ARPA2021_PublicLibraries)). The application deadline is August 9, 2021 for a planned disbursement of funding by October. The department invites you to sign up for a listserv dedicated to discussions about ARPA and other grants. Feel free to sign up and swap ideas [there](#).
